August 2019 Regular Meeting

New Business

Board Policy Amendments and Annual Work Plan

The first order of new business saw the Board of Education review Board Policy 1. The policy is reviewed annually to ensure that Division targets are reflective of the provincial Education Sector Strategic Plan. Goals written under the Student and Family focus have been set as incremental improvements versus a defined percentage goal. The change was made to make the goal setting more reasonable and achievable. The Truth and Reconciliation goal as written in the 2018-19 Strategic Plan was removed under Student and Family and has been replaced with two new goals under People Capacity. The goals remain linked to Truth and Reconciliation and increasing competencies regarding Indigenous history and culture as well as focussing on fostering existing, as well as developing new partnerships to increase educational opportunities for our Indigenous students. The Board of Education has also approved a new goal under Student and Family regarding Parental Engagement. Financial Report

Macdonald School – Naming of School Library

The Board of Education, together with Director/CEO approved the request from Macdonald School in Stockholm, to name the school library in honour of a former student who had a tremendous impact on both the school and the community.

Preeceville Senior Girls Volleyball Co-op

The Board of Education passed a motion to approve an application put forward by Preeceville School to have their Senior Girls Volleyball team join with the Kelvington High School Girl's Volleyball team (Horizon School Division) in a Cooperative Sponsorship through the Saskatchewan High School Athletics Association (SHSAA). Despite low numbers of participants, this will allow the Preeceville girls an opportunity to compete in High School Athletics within a neighboring school division. The GSSD Board of Education values extra-curricular opportunities and is pleased to approve this opportunity.

Yorkton Regional High School/ Kamsack Comprehensive Institute Football Co-op

The Board of Education passed a motion to approve an application, which will see students from the Kamsack Comprehensive Institute join with the Yorkton Regional High School in a Cooperative sponsorship through the SHSAA. This will allow students from Kamsack the opportunity to compete as members of a GSSD football team in a neighboring community while playing a sport they love.
