Highlights of the GSSD Board of Education Meeting

March 31, 2022

March 31, 2022 Regular Meeting

The Regular Board meeting for March 2022 originated from the Birch Room at Good Spirit Education Complex on March 31, 2022. Trustees who were in attendance included: Chairperson Bob Simpson, Vice Chairperson Jaime Johnson, Trustees Jade Anderson, Chris Balyski, Shannon Leson, Jan Morrison, Lois Smandych, Nicole Pohl and Steve Variyan. Division office staff in attendance included Director of Education/CEO Quintin Robertson, Chief Financial Officer Keith Gervais, Superintendent of School Operations Mark Forsythe, and Executive Services Supervisor Heather Morris.

Approval of Minutes

Advocacy Session

Saskatchewan School Boards Association

The Board of Education held an advocacy session with Darren McKee, Ted Amendt, and Felice McKay from the Saskatchewan School Boards Association (SSBA). They are looking at ways of creating more opportunities for the election and participation of Indigenous school board trustees.

Director Robertson shared that GSSD held the first Indigenous Advisory Committee meeting in March 2022. The committee consists of representation from the following First Nations: Kahkewistahaw, Cowessess, Cote, Ochapowace, Key, and Keeseekoose. The committee is still looking for representation from Little Bone First Nation. The GSSD Board is hopeful that a member from this committee will be an elected member in the future, following the change in legislation.

McKee acknowledged that GSSD is on a positive pathway and thanked the Board and Division for their commitment in continuing to build partnerships and relationships with the First Nations.

Accountability Report

Effective Policy & Procedures – Payroll

Raquel Spilchuk, Payroll Supervisor, and Payroll Assistants Kim Davis, Jaime Kennedy, and Monica Morgan joined the meeting at 11 am to present the accountability report. Chair Simpson welcomed the members of the Payroll Department and thanked them for their due diligence and acknowledged how prepared the team is during the audit each year.

The department is comprised of three payroll assistants and one supervisor with a full-time equivalent of 3.78. To mitigate risk within the department, the team is currently engaging in cross training in the areas of support staff pension administration and preparation of T4's.

As outlined in the accountability report, substitute payroll costs increased in 2021 compared to 2020. Spilchuk reminded the Board that school had moved to supplemental learning in March 2020 to June 2020 due to the pandemic therefore substitutes were not required.

The Team is excited about attending an Atrieve one-day session in Saskatoon on May 2, 2022. This will allow them to refresh their skills in the payroll software while providing a networking opportunity with other divisions who are currently using Atrieve.

Robertson & Gervais shared how confident they are in the Payroll Team and commended them on their thoroughness and accuracy.

Board Development

Understanding Financials

Keith Gervais, Chief Financial Officer, provided an overview of the 10 fast facts about understanding financials.

- 1. What are Financial Statements?
 - a. Financial statements are reports that summarize important financial accounting information about the division. They are like the financial dashboard of the school division. There are three main types of financial statements: the balance sheet, income statement, and cash flow statement.
 - b. Financial statements are audited annually to ensure accuracy.
 - c. Provincial Auditor reviews GSSD financial statements approximately every three years.
- 2. Balance Sheet
 - a. A snapshot of school division finances at a certain moment in time. The balance sheet is broken into three general categories including Assets, Liabilities, and Equity.
 - b. Can also be called the Statement of Financial Position.
- 3. Assets
 - a. Items of value that the school division owns.
 - b. Includes cash & cash equivalents, accounts receivable, investments, furniture & equipment, land, buildings, vehicles, etc.
- 4. Liabilities
 - a. Debts owed to others such as accounts payables, long-term debt, or deferred revenues.
- 5. Equity
 - a. Remaining value of the school division after subtracting the liabilities from assets.
- 6. Balance sheet formula
 - a. Equity = Assets Liabilities
 - b. The school division value consists of what is owned (assets) minus what is owed (liabilities).
- 7. Income Statement
 - a. Called the Statement of Operations and Accumulated Surplus from Operations in school division financials.
 - b. Focuses on revenues and expenses during a particular period of time.
 - c. Expenses are subtracted from revenues to determine operating surplus or deficit.
- 8. Cash Flow Statement
 - a. Measures how well cash is generated to pay any debt obligations, fund operating expenses and investments.
- 9. Accrual Accounting Method
 - a. Recognizes revenue when it is earned and expenses when they are billed out.
 - b. Gives a more realistic idea of revenue and expenses during a period of time.
- 10. Cash Basis Accounting
 - a. Recognizes revenue and expenses only when money changes hands.
 - b. Does not recognize accounts payable or receivable.

Facilities Tour

Grayson School is a Kindergarten to Grade 9 school with a current enrolment of 54 students. The school saw some renovations in 2018.



The Grayson School Community Council (SCC) and Staff worked together with a goal to develop a program that would help make Grayson School distinct by offering a unique and innovative program.

- This led to developing a STEAM program (Science, Technology, Engineering, Art, and Math).
- The SCC fundraised over \$10,000 to renovate the old computer lab into a space to house this program.
- Funding was used to purchase new furniture, tech equipment, coding kits, etc.
- Steam is offered to grades 1-6 to supplement their Math and Science instruction.
 - Students work through the engineering design process to try to accomplish a variety of different tasks. The main focus is on problem-based learning where students are given a challenge, or a problem and they work through the steps to try to solve that problem.

In spring of 2021 Good Spirit School Division was approached by the Grayson Community Daycare Committee to discuss a potential partnership that involves a portion of the school being used for a daycare.

- Members from GSSD met with the Daycare Committee and a ministry representative to review the space, determine what was required, and discussed information needed for the committee to complete their application.
- In March of 2022, news was shared that funding was approved for 20 daycare spaces
- GSSD and the Committee recently met, and a plan is in the works. 1080 Architecture is being brought in as design consultant working hand in hand with the committee while being supported by GSSD.
- The daycare will use classrooms 117 and 113 as well as share the Home Ec Kitchen 111.

Education Updates

GSSD Transition Planning

Director Robertson shared that a transition is a process that requires the ongoing support of team members throughout the school and division. It is the time in which a child gradually adjusts to their new surroundings. Transitioning involves the physical, social, and emotional well-being of a child and considers individual learning needs and accommodations. Planning will be different for every student. Some students will require more supports and planning than other students.

A road map is created to ensure the successful transition of the child and the family and Team planning is required to successfully provide opportunities to students. There are transition plans developed for English as a second language students, students who have been absent for a prolonged period of time, when a student requires support with a specific learning need or accommodation, and occasionally when a student moves from one classroom to another.

Members of the transition planning team may include students, immediate family members, extended family members, caregivers, classroom teachers, student support teachers, administration, educational assistants, professional service providers, student services coordinators, and other agency personnel (PECIP, health professionals, Community Living and the Ministry of Social Services, Partners in Employment, and SK Abilities).

myBlueprint

Kristen Myers, Curriculum Consultant, provided an overview of myBlueprint to the Board. She explained that *myBlueprint* is an online planning tool for students and their families. It is a digital portfolio, education and career/life planning resource that can assist students in developing individualized graduation and post-graduation plans.

All Grade 7-12 students in Saskatchewan are provided with a *myBlueprint* account through the Ministry of Education. Students can connect their parents/guardians to their account as well. As an action implemented in the former Education Sector Strategic Plan, Grade 9 students are expected to develop and maintain graduation and post-graduation plans to support their transition through secondary school and beyond. A recommendation to "ease transitions to life beyond Grade 12 by providing more knowledge about diverse career pathways" has been provided as part of the continued development of the *Provincial Education Plan Framework*. Graduation plans and career pathways can be developed and maintained using *myBlueprint*.

Select features of *myBlueprint* include:

- "Who Am I" assessments and job-specific compatibility surveys that help students discover their learning and personality styles, interests, desired knowledge, and motivation factors, connecting them with future career possibilities.
- The ability to search, filter, and compare local, provincial, and national information about apprenticeships, colleges, universities, and occupations to inform students' decision-making and preparations for the future.
- An online, interactive portfolio where students can keep track of important experiences, activities, achievements, and skills with documents, images, videos, and more. Students can then easily share an interactive portfolio link with others.

To date, 1,638 students in Good Spirit have logged in to *myBlueprint* this school year. Usage has increased over last year in Grades 8-12. The highest usage currently occurs in Grade 9, when students are beginning to create their graduation and post-graduation plans.

A series of three training sessions has been offered for staff this school year:

- March 2: "Using myBlueprint to Support Career Education in Grades 7-9"
- March 23: "Graduation and Post-Secondary Pathway Planning Using myBlueprint"
- March 30: "Using myBlueprint Beyond the Basics"

Resource Selection Committee

Susan Robertson, Curriculum Consultant, and Kendra Helfrich, Instructional Coach, joined the meeting to provide an overview of the Resource Selection Committee. The committee realized they didn't have a clearly defined process for the selection, purchase or weeding of resources in GSSD.

Looking at how the resources align with the GSSD strategic plan, they wanted to ensure all the resources in the Centralized Library and in schools – those being taught and future purchases – align with the vision, values, and aspirational statements:

- Vision removing barriers to ensure achievement for all.
- Values ensuring all our resources foster and promote belonging, respect, responsibility, learning, nurturing, perseverance, and diversity.
- Aspirational Statements opening the dialogue about how each of our resources supports high-quality teaching and learning, promoting engagement of all students, families, and communities, and contributing to healthy, sustainable physical & social environments. Reviewing policies to reduce barriers and enhance student success.

The committee wants to ensure that all resources are being vetted through a process guided by these statements, The Saskatchewan Curriculum, Administrative Procedure 270, and The Resources Learning Guidelines 2020.

There is a broad representation on the Committee including Jess Armstrong (Indigenous Student Success Consultant), Kendra Helfrich (High School Instructional Coach), Shawn Kostiuk (Digital Consultant), Lisa Wotherspoon (Superintendent of Curriculum, Assessment, and Instruction), Kerrilyn Trost (Elementary Instructional Coach), Sheila Tillman (Lead Librarian), and Susan Robertson (Elementary Curriculum Consultant).

The Committee is reviewing the Learning Resource Guidelines 2020 from the Ministry of Education to make informed decisions moving forward and are in the process of creating a checklist for the review of materials.
