HIGHLIGHTS FROM THE JUNE 15, 2023 MEETING



June 15, 2023 Regular Meeting

The Regular Board meeting on June 15, 2023, was held at the Good Spirit Education Complex. The following trustees were present: Chairperson Jaime Johnson, Vice Chair Steve Variyan, Jade Anderson, Chris Balyski, Gilda Dokuchie, Shannon Leson, Bob Simpson, Lois Smandych, and Nicole Pohl. Also in attendance were division office staff, including Director of Education/CEO Quintin Robertson, Chief Financial Officer Keith Gervais, and Executive Services Supervisor Heather Morris.

Meeting Opening

Board Chair Johnson commenced the meeting at 10 am.

Trustee Pohl respectfully recognized that the meeting was taking place on Treaty 4 Territory; the traditional territory of the Anishinaabe, Cree, Assiniboine, and homeland of the Métis Peoples.

Approval of Minutes

The meeting package included the minutes for the May 4, 2023, Regular Board Meeting and the May 25, 2023, Special Board Meeting, which were prepared by Executive Services Supervisor Heather Morris. Delegation

As outlined in Board Policy 7, the Board will make provision for a delegation to make a presentation at a Board meeting in the interest of improving the education provided in Division schools.

During the Regular Meeting on June 15th, two delegations were approved to address the Board.

Accountability Report

Transportation

Ryan Hall, Transportation Manager, provided an overview of the targets, data, key strategies employed, future strategies, risk assessment, and summary comments during the accountability report on Transportation.

Targets:

- Minimizing ride times.
- Collaborating with HR and other divisions to enhance recruitment strategies.
- Analyzing fuel usage to minimize costs.

Data:

- Route cancellations categorized as mechanical, weather-related, medical, personal, and other.
- Information on ride statistics, including the number of students transported, daily kilometres, longest ride times, and average ride time.
- Updates on bus and vehicle purchases for the division.

Key Strategies Employed:

- Collaborating with Human Resources and Payroll for educational assistants to obtain their S-endorsement, offering a monetary bonus as an incentive.
- Building relationships between bus drivers, administrators, and families.
- Implementing BusPlanner Web as a school locator and transportation eligibility tool.
- Conducting discussions with bus drivers and local government officials regarding road conditions.
- Providing training for bus drivers, introducing new software, and complying with electronic safety inspections.

Future Strategies:

- Fully implementing BusPlanner Workflow for charter bus requests.
- Analyzing Administrative Procedure related to school closures or inclement weather and student transportation.
- Developing a five-year fleet renewal plan.

Risk Assessment:

- Assessing the impact categories of financial, reputational, managerial effort/capacity, government relations, legal, and student outcomes.
- Likelihood of identified risks assessed as rare.

Summary Comments:

- GSSD has seen an increase in ridership with improved efficiency and reduced ride times.
- Fewer cancellations due to the availability of spare drivers and favorable weather conditions.

The Board approved the accountability report on Transportation and acknowledged the report met the requirements of QIs 1.2, 5.1, 6.2, and 7.2, based on the evidence within the report.

Board Development

Why We Do Land Recognitions

Chair Johnson posed a question to Jess Armstrong, the Indigenous Student Success Consultant, asking for an explanation of what a treaty is. In summary, Armstrong responded by stating that treaties are agreements designed to establish and maintain a partnership between the Crown, Government, and First Nations. Treaties are legally binding agreements and

are meant to establish a framework for peaceful coexistence and collaboration among nations.

Armstrong highlighted the significance of Indigenous Identity, emphasizing that it encompasses a deep connection and knowledge of the land. Through acknowledging the land, we also acknowledge its original inhabitants of this land. We recognize the oppression and injustices they endured in the past and continue to face today. By recognizing the land and the Indigenous people of this land, we renew our commitment to not only the treaty relationship but to continuing to build relationships with Indigenous people.

Relationship Building/Advocacy Session

Saskatchewan School Boards Association

Representatives from the Saskatchewan School Boards Association (SSBA), including Jaimie Smith-Windsor (President), Shawn Davidson (Vice President), Darren McKee (Executive Director), and Robert Bachman (Constituency Representative), joined the Board via Teams. The purpose was to foster communication, address inquiries, and discuss the SSBA's role in advocating for its members.

The session focused on fostering relationships, amplifying local voice, and discussing advocacy campaigns and initiatives. Topics included membership fees, voting structure, local voice importance, advocacy strategies, and board and public engagement. Director Robertson emphasized ethical alliance-building, while Jaimie expressed gratitude for Trustee Smandych's pandemic efforts.

During the session, participants explored various strategies aimed at strengthening the role of locally elected school boards. These strategies included promoting public involvement, utilizing videos to raise awareness, and fostering engagement with School Community Councils (SCC). The importance of engaging Members of the Legislative Assembly (MLAs) and facilitating knowledge sharing was emphasized.

Chair Johnson delivered closing remarks and emphasized the significance of implementing the discussed strategies at the division level. Appreciation was expressed for the support received and the exchange of communication ideas. Participants were encouraged to actively participate in the renewal of the SSBA Strategic Plan by providing input through surveys.

Both board members and SSBA representatives expressed gratitude for the productive discussions that took place and reaffirmed their commitment to ongoing collaboration and cooperation.

New Business

School Community Council Loans

In response to the request made by the Yorkdale Central School Grade 6 to 8 students through the School Community Council (SCC), plans are underway to upgrade their section of the school grounds. The SCC has initiated research into the feasibility of installing a pair of gazebos. These gazebos would serve as a versatile gathering space for the older grades, accommodating activities such as outdoor classes, presentations, events, and more.

To support this endeavor, the SCC has consulted with the GSSD Facilities department. Discussions have been held regarding the relocation of existing sheds and the placement of the new gazebos in the designated area. The collaboration between the SCC and the Facilities department aims to ensure the successful implementation of the project.

The Board made a motion to approve the School Community Council loan application for the Yorkdale School outdoor classroom project.

The Columbia School Community Council (SCC) is committed to enhancing the Columbia School playground, with a two-fold plan:

- 1. Revitalizing the playground space to create an improved recreational area for the students.
- 2. Establishing a large outdoor learning space with shade and seating, enabling teachers to conduct classes outdoors.

To accomplish these goals, Columbia School has been collaborating with Playquest. The estimated timeline for the project includes an installation date in August. The SCC is actively working towards providing a revitalized and engaging playground experience for the students of Columbia School.

The Board made a motion to approve the School Community Council loan application for the Columbia School playground and outdoor classroom project.

Facilities Update

Pat Morrison, Facilities Manager, provided an overview on the status of facility projects, maintenance, and other facility related items.

Here is a summary of the provided information:

- 1. Current Projects Active Design:
 - Canora Composite School: Design phase for roof and envelope issues (Phase 1).
 - Good Spirit Education Complex: Planning for parking lot improvements including rail for walkway and jersey barriers.
 - Davison School: Planning support for barrier-free playground path.
 - Churchbridge Public School: Planning to replace main backboards in the gym.
 - Macdonald School: Planning for water softener addition.
 - Yorkton Regional High School: Planning for relocation of reset button for the divider wall in the gym.
 - Yorkton Regional High School: Tender for parking lot recap and extension.
- 2. Current Projects Scheduled:
 - Various schools have scheduled projects, such as concrete step installation, washroom upgrades, computer lab renovation, drainage system installation, gymnasium floor replacement, etc.
- 3. Current Projects Work in Progress:
 - Ongoing projects include site drainage, room renovations, boiler room renovation, daycare flooring and countertops, etc., at different schools.
- 4. Recently Completed Projects:
 - Completed projects include track repairs, office renovations, surveillance system replacement, storage shed construction, etc.

Facilities Tour - Yorkdale Central School



The school is configured for grades K-8 and has a total size of 5215 m2 (56,133 ft2). It was originally built in 1959 and has undergone several additions in 1967, 1976, and 1984 to accommodate additional classrooms, a student center, performing arts facilities, and administrative offices. The current enrollment for the 2022/23 academic year is 464 students, with 25 classrooms and 1 gymnasium available. The school also features facilities such as a library, wood shop, performing arts area, band room, workout area, home economics lab, and a student center.

Recently completed projects at the school include the Home Economics lab, fitness area, phone system, PAA doors, and a portable roof top HVAC unit. Planned projects include replacing the asphalt shingles on the student center with tin, concrete repairs, roof replacements for sections 2, 4, 7, and 10, constructing a concrete ramp to the PAA doors, and a boiler replacement with a mechanical room renovation.

Principal Dennis Nesseth is highly regarded as a great ambassador for GSSD's commitment to serving students. He consistently prioritizes the well-being and educational experience of the students at the school. The Facilities Team enjoys collaborating with Dennis and his staff, as they share a common goal of improving the overall student experience.

Student Incident Report

School staff and administration utilize a behaviour tracking system called Review 360 to document incidents of concern, which can be accessed by the in-school administration and senior leadership to address office-level referrals. One possible consequence of such referrals is suspension, either in-school or out-of-school. To determine when a suspension is necessary, process and practices have been established to support in-school administration.

Robertson presented a report on student incidents of concern, which included 16 out-of-school suspensions that occurred across the Division between April 28 – June 8, 2023. In response to these incidents, school administration and staff provide support to their students by implementing various measures.

Since the last Board meeting, only one Administrative Procedure (<u>AP 175 Workplace Violence</u>) has been reviewed, finalized, and made available on the GSSD website.
