Dear Good Spirit School Division Families,

The Saskatchewan Teachers' Federation (STF) has announced that there will be a one-day rotating withdrawal of noon-hour supervision for STF members in select divisions on Tuesday, March 19, 2024. **Good Spirit School Division is upon the select school divisions that will be affected by this action on Tuesday, March 19, 2024.** This job action is part of the collective bargaining process.

What This Means for GSSD Schools on March 19, 2024:

- Withdrawal of Noon-Hour Supervision: All STF members will not provide noon-hour supervision on this date. They will leave their place of work during their assigned noon hour.
- Request for Family Support: We encourage families who can arrange for their children to be at home during the noon hour on Tuesday, March 19, to do so. This will significantly ease the pressure on our schools during this time.
- Contingency Plans for Supervision: GSSD schools have developed contingency plans to ensure that students who remain on school premises during the noon hour are supervised and safe. These plans will be in effect on March 19.
- Notification to Schools: If you plan to have your child at home over the noon hour, please inform your school beforehand. This will help us in organizing and implementing our contingency plans effectively.
- Other Activities: Extracurricular activities and before and after school programs will still run on Tuesday, March 19, 2024. If your child has an extracurricular activity during the lunch hour, this may be altered. Please inquire with your school for specific details.
